## **EXECUTIVE SESSION – PERSONNEL MATTERS**

Motion by Mr. Buck, seconded by Mr. Earman, to adjourn into executive session pursuant to Ohio Revised Code Section 121.22(G)(4) for the purpose of preparing of, conducting, or reviewing negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions for their employment. Roll call vote was taken with all members voting yea. Motion passed. Meeting reconvened at 10:36 am.

## RES. 73-06 Approve Continuation of 2006 Compensation for Contracted Firefighters

Motion by Mr. Earman, seconded by Mr. Rice, to approve continuation of 2006 compensation rates into 2007 for union contracted fire personnel due to expired contract effective January 1, 2007. Motion passed.

## RES. 74-06 Request Approval by Local 1723 of Contract Acceptance

Motion by Mr. Earman, seconded by Mr. Rice, to notify Local 1723 President, Vic Lantz, in writing of the Board of Trustees request for approval of the most recent contract document without any changes. Approval must be received by the Board no later than 11:00 am, January 5, 2007. If contract is accepted by the union, all pay increases will be effective beginning the first day of the first full pay cycle following the approval of the acceptance by the Board. Motion passed.

#### RES. 75-06 Approval of Trash Exemption Request for Earl Pfahler

Motion by Mr. Jim Rice, seconded by Mr. Earman, to approve the trash exemption request for Earl Pfahler, resident of 3520 Fishinger Road. In a letter received by Richard Wing, owner of Olentangy Building & Development Ltd., Mr. Pfahler is authorized to dispose of his trash at this business property. Motion passed.

## TRASH SERVICE

Mr. Earman requested on behalf of the Township, letters be sent to all residents who received trash exemptions for 2006 notifying them that their exemption is expired as of January 1, 2007.

The Fiscal Officer provided the Board with the notification letter from Local Waste Services verifying the 2007 monthly rates of \$13.62/month for regular service and \$12.26/month for seniors.

Mr. Buck informed the Board that Chris Crooks, resident of 4812 Bell Ann, had stopped by to provide pictures of her damaged yard. According to Mrs. Crooks, the damage was done by Local Waste Services refuse collector's truck. Mr. Buck contacted Local Waste Services and requested them to contact Mrs. Crooks. In addition, Mr. Buck requested Steve Montgomery to contact Mrs. Crooks to help her resolve the issue.

## RES. 76-06 Approval of Ohio Bar & Title for Completion of Lot Split

Motion by Mr. Rice, seconded by Mr. Earman to approve Ohio Bar & Title Services to complete the title work related to the lot split.

## RES. 77-06 Approval of Physical Fitness Program for 2007

Motion by Mr. Earman, seconded by Mr. Rice, to approve Chief Long's request for continuance of the Physical Fitness Program at a cost to the township of approximately \$43,000. Total cost for the annual program is approximately \$90,000. The township has been awarded a FEMA grant in the amount of \$50,000. Chief Long confirmed that 90% of the fire personnel are active in the program. Motion passed.

## RES. 78-06 Approval of Purchase of Physical Fitness Equipment (Elliptical Machine)

Motion by Mr. Rice, seconded by Mr. Earman, to approve the purchase of an Elliptical Machine for Fire Station 83 at a cost of \$3,337.38 per Chief Long's request. Motion passed.
