# **PUBLIC PARTICIPATION**

Township resident, Mr. Jim Rice asked the Board to consider having the drainage swale located at the front of his property and in the Township right-of-way to be reconfigured to allow for better drainage. Mr. Buck noted that Mr. Rice had received prior Board approval to tile the drainage swale if he desired. After further discussions, Mr. Rice asked the Board to table the matter until he followed up with his neighbor.

## **POLICE REPORT**

Chief Garnett reviewed the January, February, and March reports and noted that there was nothing unusual to report. He confirmed that the City of Hilliard intends to hold Mayor's Court for the first time in the Safety Services Building (SSB) on Wednesday, May 5<sup>th</sup>. Chief Garnett reviewed the computer reporting capabilities within the police cruisers and noted that the hopefully the cruisers would eventually have wireless reporting capabilities.

#### RED CROSS

Tonya Craft, Emergency Service Director of the Red Cross confirmed that the SSB has been reviewed and approved as an emergency shelter. Miss Craft noted that the SSB was a premier location and an ideal facility because of the ability to provide shelter, food, and water to a number of people for an extended period of time. Miss Craft noted that the Board would be asked to sign an Addendum of Understanding for a three year period. Chief Long noted that a coordinated drill between the Red Cross, Hilliard Police Department, and Norwich Township Fire Department would take place on April 29, 2009.

#### **FIRE DEPARTMENT**

Chief Long requested the Board to approve the computer network support renewal contract with NetWave. He noted that NetWave has provided invaluable support over the past year and was very happy with their performance. The renewal contract is approximately a 4% increase over last year's contract. Chief Long noted that Lt. Jeff Woodward was recognized by the Hilliard Optimist Club for his work with CPR training and they donated \$250 to the Township in honor of his efforts.

## **CEMETERY & ROAD DEPARTMENT**

In conjunction with Mr. Dave Ahlum of Ahlum and Arbor, Mr. Montgomery completed an inspection of tree problems along the Township roads in the right-of-way. Mr. Ahlum provided a detailed listing of corrective measures and a quote to complete the work. Mr. Montgomery noted that this was work

that the Township did not have the proper equipment to complete. The Board discussed the work and approved the quote for services. Mr. Montgomery reported that due to the prior years' preventive maintenance, the Township roads are in good condition. He recommended that the Township hold off on pursing any road projects for 2009, but, noted that if the Schirtzinger Road Project was delayed, patchwork would need to be completed along Schirtzinger in the fall. Mr. Cope requested a status update on the Schirtzinger Road Project by the next meeting. The Board agreed that the retaining wall was a separate piece of the Schirtzinger Road Project. In other matters, Mr. Montgomery reported that Danford Square would be fixed without any cost to the Township.

## FISCAL OFFICE

Mrs. Miles noted that the post audit follow up meeting the State Auditor's Office has not been scheduled.

## TOWNSHIP ADMINISTRATION

Mr. Warner reviewed the three landscape maintenance quotes and recommended the Board approve an agreement with Mutter's Lawn Service. At the direction of Township legal counsel, Mr. Warner asked the Board to direct Loveland and Brosius to draft correspondence to Converse Electric notifying them that their claim for damages to switching equipment in the construction of the SSB was denied by the Township's insurance carrier. Mr. Warner reported that the replacement fence parts should be arriving next week.

Mr. Buck reported that Brown Township Trustees invited the Board to attend their April 20th meeting.
