FIRE DEPARTMENT

Chief Long reported on the state enacted changes to EMS billing for nursing homes. He noted that the changes only impact patients who are residents of the nursing home. He recommended that the Township accept the Medicaid reimbursement rates for transports from nursing homes. Chief Long reported that the Dispose of Unwanted Medications Properly (D.U.M.P.) is scheduled for October 17, 2009. In addition, auto extrication training will be taking place August 25, 26, and 27.

CEMETERY & ROAD DEPARTMENT

Mr. Montgomery reported that Ahlum and Arbor will begin removing the trees associated with the Schirtzinger Road Improvement Project this Wednesday. All residents will be notified. In preparation for the new school year, all crosswalks have been painted and brush trimming will be wrapped up this week.

FISCAL OFFICE

Mrs. Miles presented The Altman Company's pay application 200714-17 and TP Mechanical Contractors pay application 12 for approval of payment. The Board approved payment to TP Mechanical Contractors and unanimously voted to deny payment to The Altman Company due to work related to the bay floors, landscaping, and irrigation system. The Board agreed to enter into a maintenance service agreement with TP Mechanical Contractors for the Safety Services Building (SSB) HVAC system. As clarification, Mr. Buck noted that the firing range has been and continues to be used.

TOWNSHIP ADMINISTRATION

Mr. Warner reported that Township legal counsel has reached a verbal agreement with Converse Electric to drop their claim on the conditions that the Township continue a good faith effort to collect from our insurer and we enter into a maintenance service agreement for the SSB electric system.

TRUSTEE-OLD BUSINESS

Mr. Earman authorized Mr. Warner to submit a formal request to Mayor Schonhardt for the police contract renewal figures.

TRUSTEE-NEW BUSINESS

In response to a Leppert Road noise complaint received from a Davidson Road resident, Mr. Earman and Mr. Buck visited the Leppert Road address. It was determined that the homeowner no longer resides in the home and the land is being used by family members for use of their dirt bikes. According to the Davidson Road resident, repeated calls to the Hilliard Police Department have resulted in being told that there is nothing that can be done. Mr. Warner reviewed a similar complaint for the same location from March 2009. Mr. Warner stated that there are a number of ways to address the matter including the police having a presence and various laws that apply to the matter. Mr. Warner will follow up with Deputy Chief Francis to determine what action to take.
