### FIRE DEPARTMENT

Chief Long recognized Firefighters Morgan Wellman and Jake Wells for their ten years of service. In addition, Chief Long recognized the promotions of Firefighter Jake Wells to the rank of Lieutenant and Lieutenant Joe Russell to the rank of Captain. In other matters, Chief Long recapped the success of the first annual Safety Day held this past weekend. Trustee Earman noted that the event was totally overwhelming and totally awesome. Chief Long requested approval to purchase five digital portable radios from Harrison Township at a cost of \$3,000 each which is approximately \$1,500 per unit below market price. Chief Long also requested approval to purchase mobile CAD/mapping software to be installed in front line equipment at a revised cost of \$26,320. Chief Long reported that the Department has been awarded a grant from the Department of Public Safety for the purchase of a mannequin at no cost to the Township.

Mr. Montgomery requested approval to install glass block windows in the Road Department Building. Mr. Montgomery requested approval to power wash and paint the Road Department Building. Mr. Montgomery requested approval of a conditional offer of employment to James D. Hale.

#### FISCAL OFFICE

Fiscal Officer Miles requested approval to add a \$41,000 FEMA Fund appropriation to the 2010 Permanent Appropriations to account for the FEMA grant awarded for the purchase of thermal imaging cameras.

Mr. Warner reported that the exterior lettering for the Safety Services Building is currently under construction and is expected to be installed within the next few weeks. The decal lettering for the front entrance is ready to be installed. The Board discussed moving forward with developing a new Township logo.
