HILLIARD POLICE DEPARTMENT

Chief Francis provided the March 2012 and first quarter 2012 activity report. He reported that crashes were down seventeen percent and traffic enforcement was up. The top accident locations within the township are I-270, then Fishinger and Dublin Roads. Aggressive traffic control is a focus for the Department. Chief Francis reviewed his reorganization plans. Drug use has increased; in the past year the Fire Department responded to more than 80 overdose calls. The Police Department recently seized seventy grams of heroin. The reorganization changes will allow the Department to be more reactive to current issues. Chief Francis provided some samples of pole mounted displays. He is currently working on a plan for use of these displays.

FIRE DEPARTMENT

Chief Kaufman reported that Firefighter Eric Eby was recognized as Firefighter of the Year by the Optimist Club. Over 200 people attended the Pride and Ownership Conference which was hosted by Three Unit. Drug Free workplace training for employees started today. The borrowed Engine has been returned. May 1st is the scheduled Chief's dinner for the Citizens Police Academy; the Board is invited to attend.

CEMETERY & ROAD DEPARTMENT

Mr. Montgomery recommended approval of oversized headstones for the Headlee and Parson families. Following a brief discussion, the Board unanimously agreed to keep the painted edge lines along Schirtzinger Road. Mr. Montgomery has received a request from the owner of 3640 Schirtzinger Road to tie their aerator system into the storm water system located in the Township right of way. The Environmental Protection Agency has provided a Memo of

FISCAL OFFICE

Mrs. Miles reported that House Bill 66-Fraud Hotline goes into effect on May 4, 2012. The bill requires that public offices make their current employees aware of the fraud reporting system and new employees must acknowledge notification of the system. The Township staff will be notified via a message on their pay stubs in addition to an e-mail. Going forward the notification will be incorporated within the employee handbook.

TOWNSHIP ADMINISTRATION

Ms. Cavanaugh reported on the Hilliard TV meeting. The program is no cost to participants and it would require minimal time. The Township would be responsible for topic ideas, then reviewing, editing, and approving the media segments. Ms. Cavanaugh reported that quotes were received from Mutters totaling \$4,155 and Darby Creek totaling \$2,905.08 for the replacement of dead trees at the Safety Services Building. She recommended the Board accept the quote from Darby Creek.
