CEMETERY & ROAD DEPARTMENT

Mr. Thomas requested approval to seal coat the roads at Wesley Chapel Cemetery. At this time, crack sealing is not necessary. The work will be completed before Memorial Day. The dead end areas in Ridgewood have been cleaned up and mulched.

Approval to Seal Coat Wesley Chapel Cemetery

TOWNSHIP ADMINISTRATION

Mrs. Fisher requested approval of the proposed Trilogy community reinvestment area agreement as presented by the City of Hilliard. Under Section 6 of the agreement, the Township's legal counsel eliminated the area where the Township was left out of the discussions if a PILOT payment was not made by Trilogy. Mr. Buck is concerned that it does not protect the Township. He is not comfortable with how Section 6 reads, however, so long as Pete Griggs says we are protected then continue. Mr. Roberts echoed the same concern. Mr. Earman asked for a motion. Mrs. Fisher recommended a \$12 per hour wage for the part-time Township Administrative Assistant. The average needs for this position is less than four weeks per year. Mr. Buck clarified that if Sandy Miles were to come back and fill the role, she would continue at her current rate. Mrs. Fisher provided the quote from Decker Construction for the parking lot and reported that it includes removing the concrete and repaving with asphalt. Drug free workplace training is scheduled for May 29th -31st.

Approval of DMK/Trilogy CRA Agreement
